Quoting Procedure

We provide free quotes to all our clients with onsite assessments. When you contact Dixons, we will ask for your address and contact details, and book in a quote time that suits you. We estimate our quotes to range from 5–15mins onsite. Our quotes are valid for 30 days.



When do you need Council approval?

When it comes to removing a tree on your private property, it is best to assume that you do need the permission of your local council.

There are at times exemptions that may be considered when requiring a permit from council, which may include trees that are fallen, dead, dangerous or pose a fire hazard.

If you live close to bushland or in an area that is prone to bushfires, Check the 10/50 vegetation clearing entitlement area. If your property is in a designated area, the 10/50 Vegetation Clearing Scheme allows you to clear certain vegetation near your home without having to get approval from the local council or land services office.

Can I have the wood chip from my job?

Mulch produced by our woodchippers is perfect for gardens. Recycling this waste product for gardening use is perfect for weed suppression and moisture retention. We will require sufficient room to tip the mulch out of our trucks and on to the property. Ask our Dixons estimator during the quoting process or team leader on the day of the work and they'll be happy to assist.

How do you remove/prune my tree?

Dixons specialise in various forms of tree management, including tree removal, pruning, transplanting and risk assessments. All aspects of tree work require a high level of skill and planning. Dixons have developed advanced, safe practises for all aspects of tree work, including crane assisted tree removal and manual climbing / rigging techniques.

Can I have timber cut up and left onsite?

If you wish to have your timber retained on site for firewood, then advise the estimator during the assessment. Allocations will be made for our staff to cut and stack the timber in the desired size and location on the property.



What to expect on the day work is being carried out

Property owners will be greeted by the Team Leader for the team as the crew arrive on site. Dixons Team Leader will go over the proposed work, answering any questions that may arise.

Staff will establish an exclusion zone around the area of work with the use of signs and traffic cones. The team will perform safety prestart inspections and a detailed site risk assessment.

Upon completion of tree work, a review of the job will be conducted by the site supervisor and confirmed with the property owner.




Will there be any impact on my property?

Dixons maintain a commitment to preserve the spaces we work in. It is paramount that care is taken to minimise the impact of our machinery on our clients' properties.

In many cases, some of our larger machinery cannot be used due to sensitive or restricted areas. Having a diverse fleet ranging from small and large plant items allows us to allocate the most appropriate machine for the project.

There are circumstances where impact to property is unavoidable. Dixons estimator will ensure this is conveyed during the site assessment, and measures will be put in place to ensure the impact is kept minimal.



10/50 Vegetation Clearing Scheme

If you live in an area close to the bush, you need to prepare your home. The 10/50 Vegetation Clearing Scheme gives people living near the bush an additional way of being better prepared for bush fires.

The scheme allows people in a designated area to:

- Clear trees on their property within 10 metres of a home, without seeking approval; and
- Clear underlying vegetation such as shrubs (but not trees) on their property within 50 metres of a home, without seeking approval.



The distance is from the external walls of the building. It includes permanent fixed structures such as decks, verandahs, pergolas and garages that are attached to the building.

It does not include detached garages, sheds, water tanks and the like, or constructions such as paved or concreted areas.
